

**FINAL TERMS**  
**for Loan No. DH2612**  
**under Danske Hypotek AB (publ)'s Programme for Continuous Issuance of Covered Bonds**

The following are the final terms and conditions (“**Final Terms**”) of Loan No. DH2612, (the “**Loan**”) that Danske Hypotek AB (publ) (the “**Issuer**”) issues in the capital market in accordance with an agreement with the below mentioned Issuing House(s).

The Loan shall be subject to the general terms and conditions dated 9 August 2017 (the “**General Terms and Conditions**”) set out in the Issuer’s base prospectus for continuous issuance of Covered Bonds, dated 2 July 2020 (the “**Prospectus**”) as supplemented on 15 September 2020 and on 19 April 2021, and the Final Terms set out below.
