

**FINAL TERMS**  
**for Loan No. DH3112**  
**under Danske Hypotek AB (publ)'s Programme for Continuous Issuance of Covered Bonds**

The following are the final terms and conditions (“**Final Terms**”) of Loan No. DH3112, (the “**Loan**”) that Danske Hypotek AB (publ) (the “**Issuer**”) issues in the capital market in accordance with an agreement with the below mentioned Issuing House(s).
